Twarit Consultancy Services Private Limited and M/s. SEPC Limited, to deposit the balance amount of Rs.29.50 crore with interest accrued on it to the Registrar of the Hon'ble Supreme Court of India.</p> <p>2. It is to be submitted that Twarit Consultancy Private Limited had already deposited an amount of Rs. 10 Crores vide Memo dated 23/05/2025 and further deposited an amount of Rs. 21 Crores vide Memo dated 31/07/2025 aggregating to Rs. 31 Crores.</p> <p>3. The Counsel of M/s. Twarit Consultancy Services Private Limited had submitted TWO Demand Drafts on 01/08/2025 bearing Nos. 294646 and 294648 respectively dated 31.07.2025 amounting to Rs.8,38,64,772/- (Rupees Eight Crore thirty eight lakh sixty four thousand and seven hundred seventy two only) and Rs.11,35,228 (Rupees Eleven Lakh thirty five thousand two hundred and twenty eight only) aggregating to Rs. 8.50 Crores.</p> <p>4. 1. By our Order dated 21<sup>st</sup> May, 2025, we had granted time upto 31.07.2025 to deposit the balance amount of Rs.29.50 crore along with interest accrued on it. We had also made ourselves very clear that no further time would be granted for making payment of the balance amount with interest.

2. Today, when the matter was taken up for hearing, Mr. Rajiv Shakhder, the learned counsel appearing for the respondent-Twarit Consultancy Services Limited submitted that he has two demand drafts bearing Nos. 294646 and 294648 respectively dated 31.07.2025 amounting to Rs.8,38,64,772/- (Rupees Eight Crore thirty eight lakh sixty four thousand and seven hundred seventy two only) and Rs.11,35,228 (Rupees Eleven Lakh thirty five thousand two hundred and twenty eight only).
