Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Rights Issue Committee of Directors of the Company at its meeting held on 19<sup>th</sup> September, 2025 has approved the First & Final Call of ₹5/- (Rupees Five only) per partly paid equity share on 35,00,00,000 partly paid equity shares of face value of Rs. 10/- each at premium ₹ NIL per equity share which were allotted on June 27<sup>th</sup>, 2025, on Right Basis pursuant to the Letter of Offer ("LOF") dated May 22<sup>nd</sup>, 2025.
